Mr. Siciliano reported that we were notified this afternoon of our 2% and 1.85% tax collections for July. These sheets have been distributed to the board. It was reported that in 2014 through July we were at \$2.78 million, and in 2015 we were at \$2,880,000. We are right on target for July. 2014 was the best year we ever had. We are over plan by \$216,923. Mr. Morey had questions regarding the different kind of taxes. In the past, tax collections on Food and Beverage were ahead of Room Taxes. Questions were answered by Mr. McNicholas and Mr. Siciliano, that trend seems to be the same.

Mr. Siciliano asked Mr. Federici to give an update on the Roar to the Shore Weekend. Mr. Federici reported that we lost all of Thursday due to rain, and 70% of Saturday due to rain. We had a strong Friday and a strong Sunday. We were actually down about 22%. With losing a large part of Saturday and all of Thursday, we were happy with that. Additional discussion took place on the event.

For the year, we are \$191,000 over our budget. These are good numbers. We are having a good season so far.

#### C. Chairperson's Report

Mr. Byrne stated that there is one issue that he would like to address with the board and ask their approval to move forward. He was approached by the Boardwalk Special Improvement District (BSID) and the Wildwood Business Improvement District to join in a letter to the commissioners of the City of Wildwood to ask for a seat on the Beach Redevelopment Commission. It seems like the city is moving forward with that plan, per an article in the AC Press. Our position is that if the city is going to move forward with this plan, at least let us have some input, both as the business in town, and the tourism commission, and certainly it makes sense that as a tourism board, we have a seat at the table. Mr. Byrne clarified that he is asking for one seat for GWTIDA. Mr. Byrne asked for feedback and comments. From the standpoint of tourism, having a seat at the table gives you the opportunity to decide whether or not something is good for tourism.

#### **Committee Reports:**

Advertising: Ms. Murphy reported that the 3<sup>rd</sup> Icon Wall Unveiling went very well. We got over \$1 million in advertising value for 42 articles that were written about the wall. The committee also decided to look at our DVD mailer that we've been doing for the last few years and how it coincides with the Greater Wildwood Chamber of Commerce and the Greater Wildwood Hotel Motel Association Vacation Guides, and looking at the numbers and the amount of money it takes to produce the piece, we are thinking about not producing it anymore, and instead reallocating the money to something that better suits. Only 1,900 people actually called for

the DVD, as opposed to everyone else ordering online. We have a new Wildwood app. 2,100 people downloaded the app, which also has the vacation guide on it.

- Special Events: Mr. DelMonte stated that the funding application process is underway. Mr. Byrne stated that some new thoughts for general guidelines were discussed. If we are giving the funding, then we have the power to ask for some things. One of the things we might ask for is that if we feel the venue is not appropriate, a lot of the events want to go to Fox Park. Some of the new events may i.e. want to go to Fox Park, we might say we would like you to consider having the event on Pacific Avenue in order to get funding, or somewhere else so that businesses that pay the TDF fees can benefit from the event. We will also think about events on the same date. We have to be good stewards of the money. We are also starting to see similar events on the island. It is a step in the right direction.
- o Mr. Morey commented on the Hydrofest and how great of an event it was, and the organizers were great people, and he is sorry to see it go. Mr. Siciliano added that it was a great event, and the value of the event was the fact that it was a sanctioned APBA event, which carries weight and recognition. Ann Fitzgerald was heartbroken to cancel the event. It was a great event. Mr. Patterson suggested writing a thank you letter to the Fitzgerald's on behalf of the GWTIDA Board for the years that they brought such a nice event to the Wildwoods. This will be done.

Mr. Siciliano stated that we have a letter that was written to the City of Wildwood regarding GWTIDA's position supporting the development of any hotel property. We support more and new hotel rooms. Mr. April suggested that the request not come from Mr. Morey. There is nothing wrong with supporting something that enhances tourism or enhances the use of our facility.
