**THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY APPROVES THE SMG CONTRACT FOR FACILITY MANAGEMENT SERVICES FOR THE WILDWOODS CONVENTION CENTER FOR A FIVE-YEAR PERIOD COMMENCING ON JANUARY 1, 2018 AND EXPIRING ON DECEMBER 31, 2022. CONTRACT SHALL BE IN THE AMOUNT OF \$85,000 FOR THE FIRST YEAR, AND \$85,000 IN YEARS TWO, THREE, FOUR AND FIVE, ADJUSTED FOR CPI, BASED ON THE APPROVAL OF NJSEA**

**WHEREAS**, the Greater Wildwoods Tourism Improvement and Development Authority (“GWTIDA”) recommends to approve the SMG contract for Facility Management Services for the Wildwoods Convention Center; and

**WHEREAS**, the said contract approval shall be for a five year period; and

**WHEREAS**, contract shall begin on January 1, 2018 and end on December 31, 2022;  
and

**WHEREAS**, contract shall be in the amount of EIGHTY-FIVE THOUSAND (\$85,000) for year one, and EIGHTY-FIVE THOUSAND (\$85,000) in years two, three, four and five; and

**WHEREAS**, contract shall be adjusted for CPI; and

**WHEREAS**, contract shall be based on the approval of NJSEA; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Greater Wildwoods Tourism Improvement and Development Authority approves the SMG contract for Facility Management

Services for the Wildwoods Convention Center for a five-year period beginning on January 1, 2018 and ending on December 31, 2022. Contract shall be in the amount of \$85,000 for the first year, and \$85,000 in years two, three, four and five, adjusted for CPI, based on the approval of NJSEA.
