**THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT  
AUTHORITY RECOMMENDS TO ENTER INTO AN AGREEMENT WITH THE CITY OF  
WILDWOOD TO LEASE THE VFW BUILDING ON PACIFIC AVENUE IN WILDWOOD FOR  
THE PURPOSE OF SUB-LETTING THE BUILDING TO THE EAST COAST MUSIC HALL OF  
FAME FOR \$1 PER YEAR. THIS AGREEMENT WOULD BE AT NO COST TO GWTIDA.**

**WHEREAS**, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") recommends to enter into an agreement with the City of Wildwood; and

**WHEREAS**, said agreement shall be to lease the VFW Building on Pacific Avenue in Wildwood for the purpose of sub-letting the building to the East Coast Music Hall of Fame; and

**WHEREAS**, said contract shall be in the amount of One Dollar per year; and

**WHEREAS**, said agreement shall be at no cost to GWTIDA; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Greater Wildwoods Tourism Improvement and Development Authority recommends to enter into an agreement with the City of Wildwood to lease the VFW Building on Pacific Avenue in Wildwood for the purpose of sub-letting the building to the East Coast Music Hall of Fame in the amount of One Dollar per year, at no cost to GWTIDA.
