We are hoping by Friday at the latest. Ethan now would like the due diligence clock to be restarted due to not yet receiving the documents. We will probably grant this 90-day request once the documents are received.

Mr. Byrne had questions of the Sales Report regarding a new coalition of convention centers. Mr. Lynch stated that they are meeting on a regular basis. It was the idea of Mike Reynolds from Atlantic City based on something that was done in California. This is to get a master plan and have everyone on the same page. Right now, the coalition includes sales, however as it grows, it will also include operations. Also discussing repurposing of buildings and getting a few leads from Atlantic City. The coalition includes buildings such as ours, from Cape May to the Meadowlands. The main goal is that we be ready when we reopen.

Ms. Carlino discussed the Statement of Operations, which reflects the tax revenue through May. However, the history 2% tourism tax sheet reflects collections through June. Through June we received \$867,721.76 in 2% tourism tax.

D. Chairperson's Report

Mr. Byrne reviewed the Chairperson's Update with the board and discussed meetings/conference calls attended throughout the month. Also attended was a WBID Executive Committee meeting at the Greater Wildwood Chamber of Commerce.

Mr. Byrne stated that he would like to form a new committee which will be a sub-committee of the Finance Committee, called the Appropriations Committee. The role of this new "Appropriations" committee will be to discuss new legislation and infrastructure and development island-wide, and beach fees. Members will include George Greenland, Jack Morey, Brendan Sciarra, Bruce Hamlin & Tom Byrne.

What happens to the beach offset money that would come back to GWTIDA?

Municipalities may also want to add an additional tax, or raise the 1.85% tax, which could be used for a new boardwalk. It is not our battle to raise the 1.85% tax. It would be the municipalities responsibility however we thank them for bringing GWTIDA to the table.

Committee Reports:

- Advertising: Mr. Barnabei stated that the committee met and Sparkable went over search engine optimization. Mr. Rose discussed the monthly website maintenance project that they are also working on, after building our site. A re-cap and executive summary were presented to the committee. We are improving on number of unique visitors, and 70% are viewing our site on a mobile device. The mobile site is being enhanced, and the speed increased. Google search has been improved dramatically. Mr. Rose also reported that the fall campaign will be launched the first week in September. We are doing promoting through social media with workations and schoolcations. The committee also started to discuss our 2021 advertising campaign. No creative will be changed. Also, we will be going out for RFP in May or June for a new ad agency. Fuseldeas 2-year option expires on 12/31/21. Simpleview system was also discussed. Mr. Morey commented positively on the fact that we are embracing wineries, breweries and birding. Mr. Rose stated that our fall campaign is targeting couples and the older generation.
- o **Special Events:** Mr. Patterson stated that the committee reviewed 1 funding application, and the Greater Wildwood Chamber of Commerce outdoor holiday shopping village was approved. We are in a holding pattern for other funding. Also trying to get dates for our proposed calendar. The committee discussed events for 2021 island-wide and is hoping for a good year next year. Mr. Siciliano added that with every convention center event, all contracts have been re-written with 2021 dates. We are not losing these events; we are just rolling them into the 2021 tourism season. Mr. Greenland added that we have made the top 10 destinations with Trivago, and a press release has been sent out. We knocked Boston out for the #10 spot.
- o Strategic Planning: Mr. Morey stated that the Rio Grande Avenue entryway signage project is nearly complete. Also, there were 2 bids received for the wave on the concrete wall. Other projects he would like to discuss in the future include parking, skate park, and we were also asked to look at the pumping station façade on Leaming Avenue. Mr. Morey mentioned that the Pacific Avenue Redevelopment is a real project being funded in part by the CMC Freeholders, and GWTIDA has been asked to participate. There will be a 10-year PILOT program, with seed money for developers. New zoning for the area would include duplexes. It was also mentioned that there has been no new movement on the renaming of Rio Grande Avenue.

New Business – Mr. Vasser provided a State of NJ update, and discussed the budget for NJ Travel & Tourism. The Governor proposed a budget for Travel & Tourism at a little over \$10 million. We are waiting to see what the legislature will do. The good news is that is still a significant increase over prior year. We are

trying to keep NJ top of mind to our visitors. Also, we have not yet received any CARES act money.
