RESOLUTION NO. 21-05

THE GREATER WILDWOODS TOURISM IMPROVEMENT & DEVELOPMENT AUTHORITY (GWTIDA) AUTHORIZES TO AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE A CONTRACT AMENDMENT BETWEEN DELAWARE NORTH COMPANIES (DNC) AND THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY (GWTIDA) FOR FOOD AND BEVERAGE SERVICES AT THE WILDWOODS CONVENTION CENTER THROUGH DECEMBER 31, 2025. DNC WILL REINSTATE THEIR MANAGEMENT FEE BEGINNING ON JANUARY 1, 2022 AT \$92,000 PER YEAR THROUGH DECEMBER 31, 2025.

WHEREAS, the Greater Wildwoods Tourism Improvement and Development Authority (GWTIDA) wishes to authorize the Executive Director to execute a contract amendment for food and beverage services at the Wildwoods Convention Center; and

WHEREAS, said contract amendment shall be between Delaware North Companies (DNC) and the Greater Wildwoods Tourism Improvement and Development Authority (GWTIDA); and

WHEREAS, the said contract amendment shall be in effect beginning on January 1, 2022 and ending on December 31, 2025; and

WHEREAS, DNC shall reinstate their management fee beginning on January 1, 2022 in the amount of \$92,000 per year through December 31, 2025; and

NOW, THEREFORE, BE IT RESOLVED, that Greater Wildwoods Tourism Improvement and Development Authority authorizes the Executive Director to execute a contract amendment between Delaware North Companies and the Greater Wildwoods Tourism Improvement and Development Authority for Food & Beverage Services at the Wildwoods Convention Center through December 31, 2025. DNC will reinstate their management fee beginning on January 1, 2022 at \$92,000 per year through December 31, 2025.
