**RESOLUTION NO. 22-04
(OPERATIONS)**

THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY APPROVES THE CONTRACT AWARD FOR FACILITY MANAGEMENT SERVICES FOR THE WILDWOODS CONVENTION CENTER TO ASM FOR A FIVE-YEAR PERIOD COMMENCING ON JANUARY 1, 2023 AND EXPIRING ON DECEMBER 31, 2027. CONTRACT SHALL BE IN THE AMOUNT OF \$95,000 FOR THE FIRST YEAR, AND \$95,000 IN YEARS TWO, THREE, FOUR AND FIVE, ADJUSTED FOR CPI, WITH A \$50,000 CAPITAL IMPROVEMENT CONTRIBUTION TO BE USED ON A PROJECT OF OUR CHOICE. NJSEA HAS GIVEN APPROVAL OF THIS CONTRACT.

WHEREAS, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") recommends to approve the contract award for Facility Management Services for the Wildwoods Convention Center to ASM; and

WHEREAS, the said contract approval shall be for a five-year period; and

WHEREAS, contract shall begin on January 1, 2023 and end on December 31, 2027; and

WHEREAS, contract shall be in the amount of NINETY-FIVE THOUSAND (\$95,000) for year one, and NINETY-FIVE THOUSAND (\$95,000) in years two, three, four and five; and

WHEREAS, contract shall be adjusted for CPI; and

WHEREAS, contract shall include a \$50,000 Capital Improvement Contribution to be used on a project of our choice; and

WHEREAS, contract has been approved by NJSEA; and

NOW, THEREFORE, BE IT RESOLVED, that the Greater Wildwoods Tourism Improvement and Development Authority approves the contract award for Facility Management Services for the Wildwoods Convention Center to ASM for a five-year period beginning on January 1, 2023 and ending on December 31, 2027. Contract shall be in the amount of \$95,000 for the first year, and \$95,000 in years two, three, four and five, adjusted for CPI, with a \$50,000 capital improvement contribution to be used on a project of our choice. NJSEA has approved this contract.

**RESOLUTION NO. 22-13
(TOURISM)**

THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY RECOMMENDS TO AMEND THE CURRENT CONTRACT FOR ADVERTISING AND MEDIA SERVICES FOR THE WILDWOODS TOURISM AUTHORITY FOR ALOYSIUS BUTLER & CLARK. CONTRACT SHALL BE AMENDED FOR AN ADDITIONAL \$200,000.00 PER YEAR, FROM \$750,000.00 TO \$950,000.00 PER YEAR FOR THREE (3) YEARS, BEGINNING ON JANUARY 1, 2022 AND ENDING ON DECEMBER 31, 2024, WITH THE THREE YEAR TOTAL CHANGING FROM \$2,250,000.00 TO \$2,850,000.00, SUBJECT TO THE AVAILABILITY OF FUNDS.

WHEREAS, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") recommends to amend the current contract for Aloysius, Butler & Clark; and

WHEREAS, said contract shall be for advertising and media services for the Wildwoods Tourism Authority; and

WHEREAS, said contract shall be for an additional Two Hundred Thousand dollars (\$200,000.00) per year, from Seven Hundred Fifty Thousand dollars (\$750,000.00) per year to Nine Hundred Fifty Thousand dollars (\$950,000.00) per year; and

WHEREAS, contract shall be for a three-year period beginning on January 1, 2022 and ending on December 31, 2024; and

WHEREAS, contract shall be subject to the availability of funds; and

WHEREAS, the three-year term of the contract shall change from Two Million, Two Hundred Fifty Thousand dollars (\$2,250,000.00), to Two Million, Eight Hundred Fifty Thousand dollars (\$2,850,000.00) or \$950,000 per year for three years; and

NOW, THEREFORE, BE IT RESOLVED, that the GWTIDA recommends to amend the current contract for Advertising and Media Services for the Wildwoods Tourism Authority for Aloysius, Butler & Clark. Contract shall be amended for an additional \$200,000.00 per year, from \$750,000.00 to \$950,000.00 per year for three (3) years, beginning on January 1, 2022 and ending on December 31, 2024, with the three year total changing from \$2,250,000.00 to \$2,850,000.00, subject to the availability of funds.
