THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY RECOMMENDS TO AWARD A CONTRACT FOR EVENT SECURITY AND CROWD MANAGEMENT SERVICES AT THE WILDWOODS CONVENTION CENTER TO GREEN MOUNTAIN CONCERT SERVICES, INC., FOR A PERIOD OF SEVEN (7) MONTHS, COMMENCING ON JUNE 1, 2022 AND ENDING ON DECEMBER 31, 2022. PAYMENT SHALL BE HOURLY, BASED ON SERVICES NEEDED.

WHEREAS, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") recommends awarding a contract for Event Security and Crowd Management Services at the Wildwoods Convention Center; and

WHEREAS, the contract shall be awarded to Green Mountain Concert Services, Inc.; and

WHEREAS, said contract shall be for a period of seven months, commencing on June 1, 2022 and ending on December 31, 2022; and

WHEREAS, payment shall be hourly, based on services needed; and

NOW, THEREFORE, BE IT RESOLVED, that the Greater Wildwoods Tourism Improvement and Development Authority recommends the award of a contract for Event Security and Crowd Management Services at the Wildwoods Convention Center to Green Mountain Concert Services, Inc. for a period of seven months, commencing on June 1, 2022 and ending on December 31, 2022, with payment being hourly, based on services needed.
