Ms. LaBounty stated that we have received tax collection numbers for February in the amount of \$168,598. This is 4% ahead of 2023 and 59% ahead of our plan. Mr.

Sattler had questions regarding inflation, which were answered by Ms. LaBounty and Mr. Belasco. Mr. Greenland added that February totals jumped 4% ahead of last year, and these are great numbers. Thank you to Ms. LaBounty.

Mr. Federici stated that Spirit Brands was 40% down in revenue, however this year was 39% up from plan. Casino Night went very well, and we were pleased with the bar revenue generated. The Business Expo also went well, was well attended, and we received high praise from the promoter.

Mr. Belasco stated that there were no updates to the Housing Department update. Mr. Greenland voiced his concerns regarding the Madison Resort not being open, and that we had to send 60 rooms to Cape May. Hopefully, the Madison Resort will be open and ready by next month.

Mr. Belasco stated that Mr. Lynch could not be at the meeting. It was noted that the NAACP has reached out for 2025, and they were thoroughly impressed with the Wildwoods Convention Center during their event this year. They highly complimented the staff and board. Mr. Greenland also mentioned that Cheerleading has expanded through 2029. This is great for the Wildwoods Convention Center and our island. In addition, wrestling has brought 5,000 people to the Wildwoods for their tournament. Ms. Springer stated that we are back to and exceeding pre-Covid numbers.

Anticipated start date is 2025. 4) It was noted that 380 cubic yards of dirt and mulch was removed from the flower beds. 5) Irrigation pipes have been installed from Burk to Rio Grande Avenues. 6) Steiger sprayed the wildflowers as

discussed, which should have little to no maintenance. Mr. Greenland thanked Mr. Belasco for all his efforts on the flowerbed beautification project. Mr. Hamlin had questions that were answered by Mr. Belasco. As part of Rutgers landscaping curriculum, students will present plans, and have a real-world opportunity to work with us as their client, which is something they do not usually have the opportunity to do.
