(OPERATIONS)**

**THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY AGREES TO AUTHORIZE THE INCREASE OF MINIMUM ON PARKING LOT FEES AT THE WILDWOODS CONVENTION CENTER FROM \$7 PER DAY TO \$10 PER DAY, INCREASING WHEN NEEDED IN INCREMENTS OF \$5, WITH A MAXIMUM OF \$50 UNDER CERTAIN CIRCUMSTANCES AS DECIDED BY OUR PARKING MANAGER**

**WHEREAS**, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") agrees to authorize to increase the minimum on our parking lot fees; and

**WHEREAS**, the said rate shall increase from \$7 per day to \$10 per day; and

**WHEREAS**, said rate shall be increased when needed in increments of \$5, with a maximum of \$50; and

**WHEREAS**, said increases shall be made under certain circumstances as decided by our Parking Manager; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Greater Wildwoods Tourism Improvement and Development Authority agrees to authorize the increase of minimum on parking lot fees at the Wildwoods Convention Center from \$7 per day to \$10 per day, increasing when needed in increments of \$5, with a maximum of \$50 under certain circumstances as decided by our Parking Manager.

**THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY AGREES TO AUTHORIZE THE AWARD OF A CONTRACT FOR SEARCH ENGINE OPTIMIZATION (SEO) SERVICES FOR THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY AND THE WILDWOODS CONVENTION CENTER TO TEMPEST IN THE AMOUNT OF \$144,000 FOR A PERIOD OF THREE YEARS COMMENCING ON JUNE 1, 2024 AND ENDING ON JUNE 1, 2027, WITH ONE TWO-YEAR OPTION BASED ON THE AVAILABILITY OF FUNDS**

**WHEREAS**, the Greater Wildwoods Tourism Improvement and Development Authority (“GWTIDA”) authorizes the award of a contract for Search Engine Optimization (SEO) services for the Greater Wildwoods Tourism Improvement and Development Authority and the Wildwoods Convention Center; and

**WHEREAS**, said contract shall be awarded to Tempest; and

**WHEREAS**, said contract shall be in the amount of \$144,000; and

**WHEREAS**, said contract shall be for a period of three (3) years, commencing on June 1, 2024 and ending on June 1, 2027; and

**WHEREAS**, contract shall have one two-year option and be based on the availability of funds; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Greater Wildwoods Tourism Improvement and Development Authority agrees to award a contract for Search Engine Optimization (SEO) services for the Greater Wildwoods Tourism Improvement and Development Authority and the Wildwoods Convention Center to Tempest in the amount of

\$144,000 for a period of three years commencing on June 1, 2024 and ending on June 1, 2027,  
with one two-year option based on the availability of funds.
