Mr. Greenland had questions regarding Flags of Liberty, which will be happening on May 23rd at 9:00 a.m. in conjunction with our Unlocking of the Ocean event at Noon. Families and friends will gather along the Wildwoods boardwalk to unfurl veterans casket flags in a moving, patriotic ceremony. Registration is available online and headquarters will be at the convention center. Ms. Dougherty will be sending invitations out. In addition, the City of Wildwood has agreed to block off Atlantic Avenue, so that the Vietnam Wall can also be included in the event. This is open to anyone who would like to honor a deceased veteran.

Mr. Rose stated that our new advertising campaign was unveiled at the Greater Wildwood Chamber of Commerce luncheon, with a new TV commercial and all new creative. The presentation is available to whomever would like to view it.

Discussion took place on money to go towards the Wildwoods Air Show. Mr. Belasco stated that we entered into a contract with the AC Air Show air boss, David Schultz, in the amount of \$12,500.

Including all budgeted expenses and a 20% contingency, our air show budget is \$500,000. We are expecting to cover most costs with sponsorship funds.

The event fits into the weekend that used to be the Roar to the Shore weekend. The Wildwoods Air Show will take place on Friday, September 5th (practice) and Saturday, September 6th (actual show). We have received a lot of assistance and met with the City of Wildwood and North Wildwood, as well as with SJTA.

We will need a budget amendment to book acts which are outstanding.

Mr. Sattler had questions, which were answered by Mr. Belasco. It was also stated by Mr. Vasser that Atlantic City wants to see the return of their airshow in 2026. Mr. Morey had questions about fundraising dollars, which were answered by Mr. Belasco. There is a call scheduled for tomorrow with David Schultz. We are responsible for housing and rental cars. Mr. Vasser suggested that we enter into a contract with Joe Kelly, to which Mr. Belasco stated that we need to get other proposals. Mr. Greenland stated that the website for the Wildwoods Air Show is wildwoodsairshow.com
